About CPRG


The federal government has set goals to reduce greenhouse gas emissions 50-52% below 2005 levels in 2030 and achieve a net-zero emissions economy by 2050

- Created by 2022 IRA to reduce emissions of greenhouse gases and other pollutants across the nation
- \$5B allocated by EPA to eligible governing bodies to create and implement plans
- Knoxville among ~80 MSAs ranked to receive \$1M planning grant

CPRG Timeline



- Phase 1: \$1m formula grant to design climate action plans to reduce GHG emissions
- Phase 2: \$2-500m competitive grant to implement reduction measures



CPRG Planning Phase

- QAPP due ASAP
- Preliminary Climate Action Plan (PCAP) due March 2024
 - GHG emission inventories for MSA and local municipalities that opt in using GPC BASIC methodology
 - GHG emission 'fact sheets' (high-level, non-GPC) for other municipalities of MSA
 - "Priority measures" (near-term, high-priority, implementation-ready) to reduce GHG pollution, and quantification of reduction potential
- Comprehensive Climate Action Plan (CCAP) due fall 2025
 - Significant GHG sources
 - Near- and long-term GHG emission reduction goals, and strategies and identify measures to achieve those goals
- Public map showing sources of emissions throughout region
- Source data and emissions software



CPRG Implementation Phase

- Eligibility:
 - Lead entities that received phase 1 planning grants and submitted PCAPs
 - Entities that did not directly receive a planning grant but are applying for funds to implement measures included in an applicable* PCAP
 - * a PCAP that geographically covers the entity and contains GHG reduction measures that can be implemented by the entity
- Will be very competitive (30-115 grants)
 - City considering application options (standalone vs combined MSAs/state)
- Requires much more detail on GHG reduction measures and equity impact

- Our vision for CPRG planning and implementation
- Scope: emissions (GHGs + air pollutants)
 across 9 counties of MSA, with GPC compliant inventories for Knoxville / Alcoa /
 Maryville / Oak Ridge
- Sectors: Electricity generation, industry, transportation, buildings, agriculture/natural /working lands, and waste management




